Call to Order, Welcome and Introductions

Approval of Minutes from Previous Meeting

Communications

- Rob Caldwell circulated several beach safety articles from around the State. Rob also stated to the Members that his Mom had recently passed. the Members expressed their condolences to Rob.
- Phil Wotton circulated an article regarding lifeguards working long weekends and holidays.
- Eric Hellstrom circulated article regarding new research on the dynamics of a rip current. Article suggests the new way to handle being caught in a rip is to stay calm and float until the rip circulates and brings swimmer back to the shore.

 Stated that John Fletemyer will be hosting Peter Kaou, head lifeguard from South Korea. If Members would like to meet Mr Kaou, Ballou will let them know when and where there will be that opportunity. He is due to arrive in the USA in about two weeks or the beginning of October..

Joe Taylor: VP / South

My apologies for missing the summer meetings. I had all intentions of being there today. Fire staff meeting ran over and I was assigned to spend a certain amount of money by the end of the day. So, I can just report two things from south. Miami Beach is replacing all towers, building the on site at a lot on 62^{nd} st. They put them out 4 at a time colorful. Hallandale Beach will initiate first time junior program next summer. Once again sorry for the no communications. Busy summer, bit off more than I can chew. One last and sad thing. If you have not seen it on face book, Marine Safety Officer Brian Ferguson of Hollywood was found dead of a self-inflicted gun wound. - Made a motion for reimbursement of \$95.86 for lunch. Ballou seconded. Motion passed to reimburse Phil Wotton \$95.86 for lunch expenses.

Jo Wagenhals: USLA SER Report:

- The Fall USLA SER meeting will be on October 22nd in Volusia County.
- The Fall USLA National meeting will be in Denver Colorado
- Jo discussed the SER competition in Siesta Key and noted that the distribution on awards had some issues, mainly that there were not enough ordered.

New Business:

- Bob Maler Reminded everyone that they should be thinking about nominations for the FBPCA awards...Meritorious Act and Heroic Act among the others
- Eric Hellstrom reminded members that nominations for Lifeguard of the Year and Beach Patrol of the Year are due on or before the November 16th Indian River meeting. One hard copy is all that is needed at the November 16th Indian River meeting. It will need to be submitted electronically as well so it can be distributed to the voting members.
- Eric Hellstrom asked the Members for their input regarding the FBPCA joining the Florida Fire Chief's Association (FFCA). A lively discussion ensued. A vote will be taken at the December 14th Deerfield Beach meeting regarding our organization joining the FFCA.
- Eric Hellstrom made a motion to cancel the October 2016 FBPCA meeting. Breck Ballou seconded the motion and the motion to cancel the October 2016 FBPCA meeting carried.
- Eric Hellstrom read a letter from FBPCA to the State of Florida Department of Environmental Protection formulated by Tom Fogan and

Joe Westerman regarding the changing of wording on the Beach Warning signs. The proposal will ask that the words describing the purple flag be changed from "Dangerous Marine Life" to "Stinging Marine Life" with "Man-o-War, Jelly Fish, Sting Rays' written in smaller letters underneath. A motion to send the letter to the DEP was made by Eric Hellstrom, Joe Westerman seconded the motion and the motion carried to send the letter requesting the DEP to change the purple flag description to "Stinging Marine Life"...."Man-o-War, Jelly Fish, Sting Ray"

- Joe Peloquin asked the Members to fill out a survey regarding their agencies policy on alcohol consumption on the beach. He asked the members to send him their policies regarding alcohol consumption electronically. A discussion ensued about enforcement.
- Rob Caldwell discussed the importance of the FBPCA contact list and the dissemination of information to the Members.
